Councillor recognised for civic leadership

MURRINDINDI Shire Councillor Sandice McAulay has been recognised for her outstanding contribution to civic leadership and the community at the 2026 Mary Rogers Awards. The awards celebrate the contribution and achievements of women in local government and recognise outstanding civic leadership across Victoria.

Cr McAulay received the highest number of nominations for the Mary Rogers Award, reflecting the high regard in which she is held following almost a decade of civic leadership characterised by com-

passion, integrity and a commitment to bringing people together.

First elected to council in 2016, Cr McAulay has served as Deputy Mayor and two terms as Mayor, providing leadership through some of the most challenging periods experienced by the Murrindindi community, including the COVID-19 pandemic, significant economic transition and the 2026 bushfires.

Mayor Cr Damien Gallagher said, "Cr McAulay's recognition reflects her untiring commitment to com-

munity, her ability to bring people together during challenging times, and almost a decade of service characterised by empathy, integrity and a genuine desire to improve outcomes for the people of Murrindindi.

"Sandice has an ability to build bridges, listen to different perspectives and work respectfully through complex and sometimes difficult issues. That approach has earned her enormous respect across our organisation and community.

"We saw those qualities particularly strongly following the 2026 bushfires, when Sandice was a visible and trusted presence for residents, businesses and farmers. She listened, advocated and worked to make sure the experiences and needs of our communities were heard."

Cr McAulay has championed economic development and opportunities for local businesses, community resilience and sustainability, emergency preparedness, community infrastructure and inclusive

participation, and supported major strategic initiatives. She has also been a strong advocate for equity and inclusion.

Cr McAulay is a long-standing CFA volunteer and emergency management advocate and has served for several years on Council's Municipal Emergency Management Planning Committee.

"On behalf of Council, I congratulate Sandice on this well-deserved recognition and thank her for her continued contribution to Murrindindi Shire," Mayor Gallagher said.

ADH questioned about amalgamation

THE amalgamation of Alexandra District Health (ADH) and Eastern Health (EH) was announced last week following a long lead time.

The boards of both ADH and EH formally recommended the voluntary amalgamation to the Victorian Department of Health and the Minister for Health on Monday, February 16.

In light of the recent decision, ADH board chair Kim Flanagan was asked the following questions: How will ADH be represented in decision-making at EH? Has an ADH board member been appointed to the EH board? How soon will dialysis become available at ADH? What other services will become available at ADH in the next six months? Will or has the ADH board been disbanded? What level of autonomy will there be for the ADH CEO? Has Claire Palmer's CEO role been made permanent or does she remain acting CEO? Is the CEO role being abolished? Will all staff be retained?

Mr Flanagan responded, "The voluntary amalgamation of Alexandra District Health (ADH) and Eastern Health is about strengthening local healthcare and ensuring the Alexandra community continues to have access to high-quality, sustainable health services close to home.

"Planning is already underway to expand services available locally, and we look forward to sharing more detail with the community as these plans progress.

"Importantly, local leadership at Alexandra will remain in place. This was a confirmed safeguard within the boards' recommendation and the Minister's decision, ensuring there continues to be strong local leadership and connection with staff, patients and the broader community.

"The voluntarily amalgamated health service will have one CEO, supported by local leadership at Alexandra. Governance will transition to a single board structure, with local representation forming part of the new governance arrangements. Further detail will be shared as these arrangements are finalised.

"All staff will be retained as part of the amalgamation, providing continuity for our people and the community they serve.

"Our focus ahead of the transition on November 1 is on bringing the two organisations together smoothly, continuing to deliver the health services local people rely on and identifying opportunities to strengthen services locally," he said.

Kim Chadband farewelled from council

Yarck funded by Foundation for Rural & Regional Renewal (FRRR)

SEVENTY-one not-for-profits and community groups have received funding from FRRR in the latest round of the foundation's flagship Strengthening Rural Communities grant program. In total, \$1,025,724 will go toward community-led projects valued at more than \$2.4 million.

In line with FRRR's strategy, funding is being directed primarily to remote, very remote and underserved rural communities.

Even the funding awarded to inner regional locations will benefit smaller towns and outlying districts with fewer services and institutions and less ability to raise funds locally.

Locally, funding was awarded to Upper Goulburn Landcare Network in Yarck for Fencers without Boundaries. The project will support bushfire recovery by rebuilding farm fencing lost in the 2026 Longwood bushfire, improving livestock security, environmental recovery, farm resilience and community wellbeing. They received \$25,000.

The Strengthening Rural Communities (SRC) program is always open. Not-for-profit groups seeking funding are encouraged to carefully read the guidelines to ensure that the project aligns to FRRR's strategic and donor priorities, and that the group is eligible.

Provide feedback on council's Draft Municipal Recovery Plan

MURRINDINDI Shire Council is inviting community members to help shape the next phase of recovery by providing feedback on the Draft Murrindindi Municipal Recovery Plan for the January 2026 Bushfires.

Feedback closes on Thursday, September 17.

Recovery began immediately after the fires and has continued since. Communities, volunteers, local halls and recovery hubs, council, government agencies and service providers have worked together to support affected people and restore access to roads and properties, reopen key community facilities and provide practical recovery assistance.

The draft plan builds on this work and reflects feedback gathered through recovery hubs, community meetings, recovery groups and direct engagement with affected residents over recent months. It also serves as a public record of the impacts of the January 2026 fires and pro-

vides a framework for medium and longer-term recovery across the shire.

It includes actions for people and wellbeing, buildings and infrastructure, agriculture, business and the visitor economy, environment and biodiversity, Aboriginal culture and healing, and communication and advocacy.

The January fires caused deep and lasting impacts across Murrindindi Shire. One person lost his life, around 1600 private properties were affected, and 217 homes were destroyed. Farms, livestock, wildlife, businesses, roads, bridges, the Great Victorian Rail Trail and the natural environment were also lost or severely damaged.

Mayor Cr Damien Gallagher said the draft plan was an important opportunity to ensure the longer-term recovery effort reflects community priorities.

"Recovery did not start with this plan and it will not end with it. An enormous amount of recovery work has taken place since Janu-

ary, led by fire-affected communities, volunteers, council, agencies and recovery partners.

"This plan is about listening carefully to what people have lived through, what they are still carrying, and what practical support is needed now and into the future," Cr Gallagher said.

Council is asking people to check whether the plan reflects their priorities, local needs and practical barriers. Feedback can be as detailed or as simple as people choose.

The plan proposes that the Murrindindi Municipal Recovery Committee, which currently includes a range of government agencies, be expanded to include six community representatives.

These representatives will be appointed through an Expression of Interest process and will provide a link between the community and council.

The plan also proposes regular updates on recovery actions at quarterly council meetings. Com-

munity members can continue to contact their local councillor with any concerns or feedback about recovery efforts.

"Community representatives and local recovery groups will help us understand whether actions are making a practical difference, identify emerging needs and adjust our approach as circumstances change," Cr Gallagher said.

People can read the draft plan and provide feedback through council's engagement website at theloop.murrindindi.vic.gov.au/draftrecoveryplan

Feedback can be provided online, at pop-ups, through established community groups across the fire-impacted area, or by attending online information sessions.

In person chats will be at Yea Library, September 10, 9.30am-12.30pm; Kinglake Library, September 15, 1-4pm; and online sessions will be on September 9, 1-2pm and 6-7pm.

Printed copies of the plan and printed feedback forms will also be available at the Yea and Alexandra Council offices.

Cr Gallagher said council understood that providing feedback may be difficult for some people, particularly where the fires continue to affect daily life.

"Some people may want to share a lot, and others may only want to tell us one thing that would make a difference. Both are valuable," Cr Gallagher said.

"The most important thing is that community members are heard respectfully, and that their feedback helps guide recovery decisions, advocacy and communication in the months and years ahead."

Council will consider all feedback before the final plan is presented to a council meeting later this year. It will publish a *What We Heard Report* explaining the main themes, what changed and why some matters could not change.

Haines talks post, critical infrastructure and communications

MEMBER for Indi Helen Haines visited Murrindindi Shire last week, conducting various meet-ups with locals to hear their concerns.

In an interview conducted outside the Yea Post Office, she was asked about what she has been working on regarding Murrindindi Shire.

She explained, “We’re here today talking about Australia Post and postal services here in Yea, and I’m seeing this right across the electorate of Indi, but more broadly across rural and regional Australia, where there are threats that our post office services could be withdrawn, that our franchisees are being pushed at every level from Australia Post into a business model that makes running a business unsustainable.

“I’ve been campaigning very strongly in the parliament against this. We need our postal services not just for post, which is critical of course, but we need it for banking because our banks have left town, and we need it for our community engagement. It’s a place where people come and connect. It’s absolutely critical because if we lose the post office we then we lose more things in town. No post office, you start losing shops and other services... I’ve put in a detailed submission into the inquiry.”

People will have notice parcel lockers being installed around the shire and beyond. Helen said, “I think one of the challenges is working out, well, do we resist parcel lockers or do we say, okay, parcel lockers are the modern thing?”

“Let’s make sure those parcel lockers are attached to the post office and not down at some car park miles away where people don’t then come and use the post office.

Parcel collection is part of the post office income stream and parcel lockers which are located a distance from the post office takes that away.

On the other hand, if the parcel locker is attached to the post office site, then the post office operators receive less rather than nothing. As Helen said, “Less is better than nothing.”

Much also depends on the post office footprint on the land and whether there is room.

Helen added, “So postal services and banking services remain a constant issue. I think the other big issue of course is the long tail of bushfire recovery.

“We know from past experience it’s not all over once it’s over. It’s years actually and I’m going around several places today.

The slow rate of the clean-up, and the exclusion of some people from the program is also a concern.

Helen said, “And there’s different streams of clean up according to what your insurance policy says. I’ve been working very

closely with Murrindindi Shire on this.

“My big campaign from a federal perspective is that when a critical piece of infrastructure like the Fawcett Bridge is destroyed in a bushfire, it’s no good to build back the same thing. [It goes back to] Breakaway Bridge in Acheron. The bridge is still not there.

“I’ve put in submissions to the Victorian Inquiry. I’m standing up in parliament talking about this constantly. The biggest handbrake though, from my perspective as your Federal member, the commonwealth can’t do the betterment piece unless the state government asks them to.

“When you look at Fawcett Bridge, there is a clear case that they need to build it back better than the one they had. But the state government won’t contribute. They have to contribute 50 per cent and they won’t do it. The Commonwealth can’t do anything unless the state makes the application... This is playing out everywhere. I’m on the Commonwealth Parliamentary Inquiry. I’m on the Committee for Regional Australia. Everywhere I go, all over the nation, it’s exactly the same story.”

In addition, she spoke about the communications challenges during the Longwood fire.

“This has been a campaign of mine since I became an MP,” she said. “I’ve been pushing, pushing, pushing on temporary disaster roaming. Essentially if you’re with Telstra and your tower gets burnt, you’ve got no communication, even though there might be an Optus tower some by which has signal. I’m pushing the government to make sure that the telecommunications companies share the signal, not just for SOS, because it’s not just SOS. You need to tell your family to get out, or you need to let somebody know that you’re all right. You need to be able to receive the warnings.

I’ve put in private members’ legislation about this. There’s a big bill before the parliament. We’re hoping for a debate next week. I’ve been working very closely with the Minister’s office to write into that bill, to amend it to make it law that they have to do this. Now she’s very reluctant to do that, but there’s other amendments in there. She’ll give me some.

“But in the meantime, the telecommunications companies are promising we’ll have temporary disaster roaming. I don’t believe it till I see it. But you’ll hear from me loud and clear once we get that. I’m looking for an announcement in October, November.”

Generators at some of the phone towers only hold a minimal level of fuel, so when there’s a blackout, there may be coverage for some time, but often not for the entirety of the blackout. This became particularly pertinent during the Longwood fire and associated blackouts.

Helen said, “I’ve put legislation before the Parliament about this. There is a program which funds battery backup and diesel backup. I’ve been campaigning hard but it’s not hard to identify the most at-risk sites in the country and Indi’s one of them.”

81 per cent would wait too long

A CFA survey has found most Victorians living in bushfire-prone areas understand leaving early is the best way to protect themselves and their families during a bushfire, but most would wait too long to act.

CFA's annual post-season bushfire community survey found 88 per cent of respondents agreed or strongly agreed that leaving early was the safest option.

However, 81 per cent indicated they were unlikely to leave until fire was threatening the landscape.

Concerningly, 12 per cent indicated they would stay and defend.

CFA Chief Officer Jason Hefferman AFSM said the results showed important bushfire safety messages

are reaching communities, but there was still work to do.

"It's encouraging to see so many Victorians understand that leaving early is the safest way to protect themselves and their family," Jason said.

"But knowing that leaving early is safest and knowing when to act are two different things. Leaving early means leaving the area before a fire starts, not when you can see flames or smell smoke.

"CFA's position is clear, do not stay and defend."

The results also showed 93 per cent of respondents have a bushfire plan, but only 13 per cent have it written down.



"A good plan should cover when you will leave, where you will go and what you will do if your preferred route is no longer safe. Writing it down and placing it somewhere you can see it can make a

huge difference during an emergency," he said.

Expectations of emergency services also remains high, 63 per cent believed they were likely or very likely to receive assistance from fire trucks to defend their property, while 77 per cent expected emergency services to tell them when to leave.

"During a bushfire, we cannot guarantee a fire truck will be at every property," Jason said.

"Don't wait for a fire truck or a verbal warning from firefighters to act. Download the Vic Emergency App, set a watch zone, listen to emergency broadcasters and monitor social media

and the CFA website for updates.

"With hot and dry conditions expected across much of Victoria this spring, now is the time to prepare.

"The best way to prepare now is to attend a Get Fire Ready event this October, speak with your local brigade, understand your risk and make sure your plan is ready before a fire starts.

"Last year, we saw 537 brigades directly engage more than 40,000 people about fire safety at Get Fire Ready events. This year we're hoping to increase that number."

Line-marking completes Buxton Hall Maintenance Appeal

THANKS to a break in the recent wet weather, the driveway area in front of the Buxton Memorial Hall received a refresh on Friday, August 28, with new line-marking completed.

The original line-marking, completed when the hall was refurbished around 2010, was so faded that the parking spaces were indistinguishable. There was also a need to include a dedicated disabled zone to the parking area and clearly indicate one-way traffic flow from Maroondah Highway towards Buxton Rise.

When council established the new community parking area in Buxton Rise, behind the hall, the original disabled parking space for the hall was removed. As a result, it was decided a new disabled space should be provided in front of the hall and Buxton Progress Association (BPA) sought funding assistance from council through their Quick Response Grant program.

The line-marking works were added to the Buxton Hall Maintenance Project, in addition to the recently completed external painting and installation of an additional garden tap. The Maintenance Project has been funded through a very successful community fund-raising appeal.

Murrindindi Shire Council awarded \$1000 in the grant request which has topped out the \$12,000 appeal target. In applying for the grant, BPA was assisted by council's Assets team, with advice on the disabled parking zone layout, and received guidance from the Community Wellbeing team in submitting the grant application.

BPA would like to thank everyone from the Buxton and wider Triangle community who contributed to the Hall Maintenance Appeal. Just on \$12,000 has been raised from individuals, community groups and council.

This has enabled the outside of the hall to be repainted, an external tap installed at the rear of the hall, and now the parking area to be refurbished and a dedicated disabled parking space added.

Enrol for the Kinglake Ward by-election

MURRINDINDI Shire Council is encouraging Kinglake Ward residents to make sure they are enrolled to vote and that their details are up to date ahead of the upcoming Kinglake Ward by-election.

The by-election will elect a new councillor to represent Kinglake Ward following the resignation of former Councillor Jodi Adams in August.

The Victorian Electoral Commission (VEC) will conduct the by-election, with the electoral roll closing at 4pm on Wednesday, September 23.

Mayor Cr Damien Gallagher said, “Having a local Councillor representing the interests and priorities of Kinglake Ward is incredibly important, and I encourage everyone who is eligible to participate in the by-election.

“The first step is to make sure you are enrolled and eligible to vote before the roll closes. I encourage people to visit the VEC website to check their eligibility and enrolment requirements.

“Local government makes decisions about many of the services, facilities and issues that affect our communities every day, so this is an important opportunity to have your say on who represents Kinglake Ward,” he said.

To vote in the Kinglake Ward by-election, you need to be enrolled for Kinglake Ward. This includes eligible voters enrolled on the Victorian electoral roll who live in Kinglake Ward. Some people who own property in Kinglake Ward but live elsewhere may also be eligible to enrol and vote in the by-election.

Enrolment requirements vary depending on your circumstances. If you live in or own property in Kinglake Ward, check your enrolment status and whether you need to take any action before the enrolment deadline. You can do this by visiting the VEC website vec.vic.gov.au/voting/current-elections/murrindindi-shire-council-kinglake-ward-by-election to check eligibility and enrolment requirements before the electoral roll closes.

The election will be conducted entirely by post. Ballot packs will start being mailed to enrolled voters from Monday, November 16, with voting closing at 6pm on Friday, December 4.

People interested in standing as a candidate will have an opportunity to learn more about the election process, with a candidate information session scheduled for Wednesday, October 14. Candidate nominations will open on Monday, October 19 and close on Tuesday, October 27.

THE POWER OF AN R U OK? CONVERSATION

NEW research has revealed that one in three people underestimate the difference they can make by asking someone if they’re okay, yet the vast majority of people who have been asked felt supported and positive about the experience.

The message is simple: ‘If you’re thinking it, ask R U OK? Any Day’ and start a conversation that can change a life.

As Australia approaches R U OK?Day on Thursday, September 10, the organisation is encouraging people to act when they think someone they care about might be struggling.

Held on the second Thursday of September, R U OK?Day is the nation’s annual Day of Action, reminding people across Australia that meaningful conversations don’t have to be perfect, but they do need to be genuine and happen regularly throughout the year.

Lach Searle, CEO of R U OK?, says the findings show that while most people care deeply about others and have the best of intentions, they might still hesitate to ask. He wants to reassure everyone that you don’t need to be an expert or have all the answers.

“So many people want to help but sometimes they hold back because they’re not sure whether checking in with someone will really make a difference,” said Mr Searle. “What this research tells us is that asking ‘Are you okay?’ is often more appreciated than people realise and while a conversation might not solve everything, it lets them know they don’t have to face life’s ups and downs alone.

“If you’ve noticed someone doesn’t seem quite themselves, trust that instinct and reach out,” said Mr Searle. “A genuine conversation might help turn around someone’s day, support them through a difficult week, or be the first step towards getting through a tougher time.”

R U OK? is here to help with the four steps of an R U OK? conversation’ framework, ALEC (Ask, Listen, Encourage action, and Check in). They also offer free resources to build your conversation confidence and skills.

Principal Psychologist Rachel Clements says the findings challenge the misconception that checking in with someone won’t make a difference.

“Meaningful support doesn’t require expertise,” Ms Clements said. “What matters most is making time to ask, listening without judgement and being present.

“If you’re thinking about someone’s wellbeing, that’s reason enough to check in. A simple conversation can help someone feel seen, heard and supported.”

Alexandra recognised the importance of RU OK? Day with a movie event at the Alexandra Shire Hall on Friday, September 4. A free barbecue was provided prior to the screening of the films, *Sketch* and *Tinā*. People were then invited to stay for a coffee and chat after the event. There were also some practical wellbeing tips provided by local mental health professionals.

The event was supported by a Look Over the Farm Gate grant provided by Agriculture Victoria under the Victorian Government’s 2025 Drought Support Package.

Promised \$6m fix for shire roads

THE state Liberal Nationals have promised that Murrindindi Shire will receive \$6 million to fix and upgrade local roads and bridges under a restored Country Roads and Bridges Program.

Member for Eildon Cindy McLeish said the commitment will provide the shire with \$1.5 million every year for four years, giving council certainty to tackle priority local road and bridge projects across the shire.

The Liberals and Nationals have committed \$5 billion commitment to repair and rebuild Victoria’s state roads, eliminate one million potholes and restore a proper, planned system of preventative road maintenance. The original program was abolished by Labor in 2015.

Ms McLeish said, “Murrindindi received \$1 million a year under the former Country Roads and Bridges Program and we saw that money turned into real projects in our local communities.

“It helped council tackle road and bridge works that otherwise would have remained on the wish list for years.”

Projects supported through the former program included major bridge works at, ironically, Breakaway Bridge at Acheron and the Goulburn River crossing at Ghin Ghin.

Country Roads and Bridges funding also supported Murrindindi’s broader bridge program, including works at Taponga Road at Eildon, McGuigans Road at Kanumbra and Allendale Road at Strath Creek.

Council records also show funding allocated to Creightons Creek Road, with savings subsequently redirected to the Williams Lane intersection realignment at Buxton.

“These aren’t lines on a government spreadsheet. They’re local roads and bridges used by our farmers, families, school buses, businesses and emergency services every day,” Ms McLeish said.

“Murrindindi has hundreds of kilometres of local roads to maintain but nowhere near the revenue base of a metropolitan council.

“Labor abolished a program that worked. We will bring it back and increase the annual allocation from \$1 million to \$1.5 million.

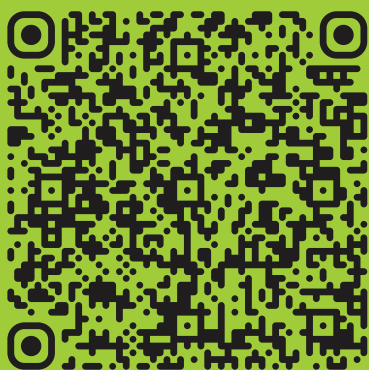
“That means a guaranteed \$6 million over four years for Murrindindi.

“We’ve seen what this program can deliver.

“Now we’re going to bring it back and get our local roads and bridges back on track.”

Bushfire recovery challenges discussed at Fawcett Hall

PEOPLE from the bushfire-impacted Fawcett and Yarck areas took the opportunity to discuss the bushfire recovery challenges with Member for Indi Helen Haines on the morning of Wednesday, September 9. The session was originally intended to last for half an hour but went much longer as Helen asked the people around the table about their experiences. The discussions outlined in this article occurred with the consent of the participants.

There was of course much discussion about the need for betterment funding for the bridge at Fawcett, as well as other fire-impacted wooden bridges in the area. This has been discussed at length previously, but as yet no solution has been found. The state government needs to trigger the betterment funding and without this, the Commonwealth's hands are tied. The community is also unable to raise the state's portion of the funds to trigger the Commonwealth support, as state money and support is required under the legislation. Helen is planning to continue lobbying for changes to the legislation, noting that the Breakaway Bridge at Acheron has still not been rebuilt following the 2022 floods.

One of the residents, Lars, spoke about losing faith in all government bodies during the fire recovery. They ended up doing everything themselves instead of waiting for the government to help with the clean-up.

He was however very pleased with Murrindindi Shire Council, approving their planning permit in three days.

He said, "But state government, and federal for that matter, they offer to come and clean up for you, and then you have to submit your life story. You have to go through Centrelink. You don't have to be registered there. It's just madness. And then it takes seven months." They wanted all of the financials of their business.

Another of the significant challenges raised was that people were ineligible for grants when they are farmers but have off-farm income. There is also a lack of mental health support for people aged 18 to 25 in particular.

Fiona said, "I think that my anger towards government is not going to go away any time soon. It's not just the fire. We've been up here for 12 years now and we've just seen systemic failures for many years... about the withdrawal of services, police, fire, roads. You only got to walk in town and see that businesses are disappearing. It's just been ongoing. And I think the bushfire just highlights the systemic failures that have been going on for many, many, many years, and the constant feel that we're just dismissed and ignored. We were abandoned... We were collateral damage for Alexandra."

A member of the Fawcett CFA Brigade spoke up, saying, "We all got told to leave Yarck and head into Alexandra to protect township and Scott our captain said I've got my own community to protect. He's a legend. The four of us came



out here. We opened the gate and protected the hall because we knew we were going to need this hall down the track for recovery... We had no support. There were three trucks on the way. We could have saved more houses down in Fawcett. But they all got redirected to Alexandra and Scott was not happy."

Fiona said that they called triple zero twice saying that their house was on fire, but that no-one came. "If that happened in Melbourne, there'd be an outrage," she said. "How dare does any government place more value on someone who lives in a built up area than us? I lost my business. that I've been running for 11 years, burnt to the ground, nothing could be saved. Our offices, gone. Our livelihoods almost gone, that we've spent decades building. Government doesn't give a s.t."

She commented on the Nepal tragedy and said, "All we're seeing is the government funding all that. What about us? What about its own citizens? And all we're seeing is the Big Build in Melbourne and all this corruption. And we can't even get a simple bridge."

She added, "If it wasn't for Sam and everybody helping out, we probably wouldn't be here."

Sam spoke of losing 18 people she had worked with during the 2009 Black Saturday fires, and while noting that the fires can't be compared, "It's de da vu. The people that have survived 2009, they've wrapped themselves around me, and I'm always so conscious when I talk about stuff that they're reliving because we're now going through it. And I know some things have changed, but when you look right across it, nothing has changed. And I think that's the frustrating thing."

Fiona also commented that the volunteer brigade system in South Australia has better procedures than Victoria.

Sharon, secretary of the Yarck Hall Committee of Management, spoke about her losses during the fire, and said that it took

six months for the Emergency Management Victoria-arranged clean-up to occur at her property. Fortunately, she had a good experience with her insurance company, unlike Bron, also in the room, who still hasn't had her insurance claim resolved.

Sharon was concerned about people who are forbidden from rebuilding on their blocks as they can't set the residence back 100 metres from the road due to the block size. She believes that people should be able to rebuild on the footprint of their former house.

Sandy said that they looked into the clean-up support but more than 50 per cent of their income if from off-farm, so she and her partner cleaned up the property themselves. They're now pivoting from livestock to hay. She was very upset with the government response, saying, "There's no urgency on recovery."

She said that for the hall, "The only thing we got from a federal aid perspective was PPE. My understanding is that the federal government has essentially a warehouse of supplies, a stockpile for emergencies internationally. I understand that there are other states that have similar stockpiles for emergencies within their own state. We don't... There's no Victorian stockpile."

She said of the clean up, "There are still people who are only just now getting their clean-up in September."

There were also wide concerns among the group that it took too long to have caseworkers on the ground. People were calling about getting a case worker and were being told that someone would get back to them in 30 to 60 days. They also found that the emergency recovery number became confusing because people didn't know what they needed and what was available. There was also the challenge of the loss of corporate memory in the recovery space as people change jobs or roles within government organisations.

Annaliese spoke about how

she came to live in the area, and their home which was lost in the fire. Despite all of their losses, Annaliese was keen to say, "We just need a bridge."

She spoke about her experiences on the day of the fire as a volunteer with the Koriella CFA Brigade, and how they couldn't go down the side roads on the day because they may have become trapped.

She found some of the police after the first to be difficult. For example, her husband needed to travel from Fawcett to Mansfield and they refused to allow him to travel along the highway. They instead sent him along Spring Creek Road and along Coles Road to reach the Highway just prior to Bonnie Doon, a much more dangerous way to go, given the fire damage.

When she had a callout, the police were telling her to find an alternate way to reach the station, the problem being that there is no viable alternative.

One of the people commented that they knew the highway had been cleared as a relative had been involved in making it safe. They went to Alexandra from shopping and the police wouldn't let them back through. She instead travelled along Whanregarwen Road to Molesworth, because locals know how to get around. Whanregarwen Road hadn't been tree-assessed and wasn't safe in the same way as the highway.

Their family also struggled to get through the roadblocks to help. It can be a difficult balance for police, trying to keep people safe and prevent looting.

While some have suggested a local permit, Helen was sceptical about whether this would help, given the challenges in the Albury area during COVID-19.

Sam Hicks, president of Fawcett Hall Reserve Committee of Management, said of the bridge, "I'm not giving up on this."

She said, "I know it's just not about this bridge, it's about all the timber bridges."

She also spoke about the time

and effort, including letters and meeting, that have gone towards the lobbying for the rebuilding of the bridge.

"Meeting after meeting," she said. "I'm sick of the lip service... Our bridge, Newman's, all the bridges in the road and the other bridges. I'm not asking for \$200 million."

She added, "We don't want to be Acheron." The Breakaway Bridge in Acheron has still not been rebuilt four years after the major flood in 2022.

Some in Fawcett are unable to access their homes when there has been rainfall as the fords put in place after the fire, in lieu of a bridge, flood.

There was general agreement that Murrindindi Shire Council's councillors and staff have been supportive around the recovery effort, with Mayor Damien Gallagher, Cr Sandice McAulay and Cr Paul Hildebrand.

"They care," one of the participants said, with others voicing agreement.

The participants said that the 'community-led recovery' is working well, as it is developed from the bottom up and provides personalised attention to people's needs, however there needs to come a time when volunteers hand over reins. "Someone needs to be there to pick up and support the volunteers as they move forward," one of the participants said. Local knowledge also needs to be passed on.

Around five to six months elapsed after the fire before they were able to close the door for recovery and it was staffed by volunteers the whole time.

Sandy said, "Community-led recovery is community are doing it and they're doing it themselves. They're reaching their networks. They're reaching out, getting donations. They're doing all of those things as all of us in the halls have done. But there does need to be a point in time so people can step back and it can transition. Not take over, not come in and allow bureaucratic rules to start to transition."

There was also a discussion around what donations are needed at particular points in the recovery process. Sandy said, "The reality is, the next time there's an event, it's going to be the people that step up that are not on the committee, on the plan, haven't read the plan, haven't had the training. It's whoever is there, people just step up and to have some resources to help you do that, I think is incredibly valuable... Skilling volunteers, providing them with information and support in an accessible manner, and the same of providing people who have been impacted in an accessible, information in an accessible manner, not thousands of posters around them, which is all the white ones."

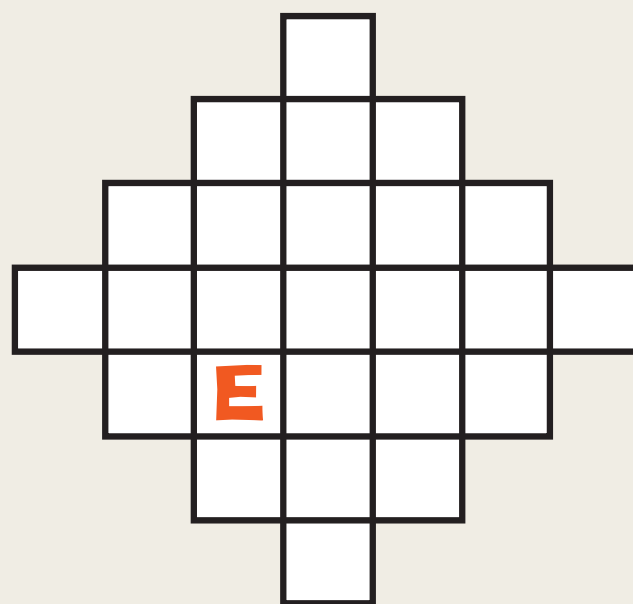
Fawcett Hall are planning a thank you event for the more than 300 individuals and 78 businesses and organisations which supported them during the recovery.

High prices and new mental health support at Yea cattle sale

THE September Combined Agents Store Sale was held last Friday at the Yea Saleyards, with prices climbing as people look to restock with lower weight cattle.

Some 1500 head of cattle were yarded, with the average price per head sitting at \$1872 and average weight at 326.5 kilogram, making for an average of 573 cents per kilogram (c/kg).

Andrew Hill from Elders Yea provided a rundown of the sale.

“It was a wintry sort of a yarding, mixed quality. The yarding wasn’t quite as good as previous sales, but overall the sale was dearer across the board,” Andrew said.

The heaviest pen of 500kg steers made \$2800. The 400-plus kg steers made from \$2100 to \$2550. In the 300kg steers range, they made \$2100 to \$2200, which is around that 600c/kg mark; very solid money.

“You come down to those 200kg Angus steers, \$1800 to \$1900, which there’s quite a few pens that made that, which comes out at 700c/kg. And there was some cattle

sold at just over 750c/kg, which is just huge,” he said.

“The demand for those younger, sweeter cattle with the right breeding and quality. They’re very, very popular at the moment. People are restocking and that’s what they want to buy. They come and buy those young steers, park them out. The spring’s shaping up very well.”

In terms of heifers, 416kg heifers made from \$2140 to \$2500. 400kg heifers at \$2050, then down to 380kg heifers at \$2070, which is good money. 360kg heifers made around \$1800. The 320 kg cattle were round about \$1620, \$1670.

“And then down to those 270kg cattle to 240kg heifers. They’re this side of \$1550, which is again over

600c/kg,” Andrew said.

“Some of those heifers, which have been sitting around the high 400 and 500c/kg for a while, but this sale, they’ve all kicked into that 550, 570c/kg. Same as the steers, they’re getting into those 640 and 700c/kg depending on quality.”

Buying support came from processors, feedlots, as well as

the local area. Cattle went as far abroad as Swan Hill, Echuca, Wangaratta, Euroa, Kyneton, Bendigo and Korumburra.

Yea and District Memorial Hospital (YDMH) were also in attendance promoting the new Mental Health and Wellbeing Local initiative.

This new initiative is a team of local providers offering free telehealth support and outreach services. The bushfire recovery team will be operating out of the Yea and Alexandra Hospitals, providing personalized support, listening and connecting people with the support they need.

The Murrindindi Mobile Health Van was also on-site, as were Murrindindi Shire Council and Dementia Australia, who offer free dementia support for those affected by this challenging condition.

The next cattle sale at the Yea Saleyards will be on Friday, October 2, with the October Combined Agents Store Sale.

How many kangaroos are around, sport

THE Department of Energy, Environment and Climate Action (DEECA) will be conducting their biennial kangaroo population surveys across Victoria from September 5 to 30.

The surveys are conducted from the air, meaning that helicopters will be flying at low altitudes and slow speeds to count kangaroos. Flights are carefully planned to avoid houses and livestock.

These surveys help improve DEECA’s understanding of Victoria’s kangaroo population and help inform wildlife management decisions.

Across the state, there are three different species of kangaroo: Red, Eastern Grey and Western Grey.

The Eastern Grey kangaroo is common, found across most of Victoria, with a grey-brown coat and silver-grey chest. They can stand up to two metres tall and weigh up to 90 kilograms.

Western Grey kangaroos are found in the north-west and western parts of Victoria, overlapping habitats with the Eastern Grey in some regions. They have a thicker, brownish-grey coat and darker grey-brown face.

They are slightly smaller and stockier than Eastern Greys.

The Red kangaroo is limited to the far north-west corner of Victoria, with males coated in brick-red fur, and females having a bluish-grey coat. They are the largest species of kangaroo.

In the 2024 kangaroo population survey conducted by DEECA, statewide estimates predicted there were around 2.09 million Eastern Greys, 212,000 Western Greys, and 39,000 Red kangaroos. This made for a total kangaroo population of around 2.34 million roos, down from an estimated 2.41 million in 2022.

The survey broke down estimated kangaroo populations by region, with Hume estimated to have 771,000 Eastern Grey kangaroos in 2024 and no Western Greys.

Kangaroos, along with all native wildlife, are protected in Victoria under the *Wildlife Act 1975*. While kangaroos are a protected species in Victoria, there are situations where they can cause damage and negatively affect farmers, regional communities and biodiversity,

leading to DEECA undertaking population control.

Kangaroo Management Plans (KMP) are developed to address risks when kangaroos are impacted by urban development, becoming displaced or landlocked.

Kangaroos are strongly attached to their home range and are reluctant to vacate an area. This can become problematic when land within their home range is subject to development, and they need to disperse to other adjacent areas.

While kangaroos may use the nearby areas, it is uncommon for kangaroos to move entirely out of their home range, even when development is occurring. This can result in kangaroos becoming landlocked, trapped on all sides by development, etcetera. Displacement and landlocking of kangaroos can cause adverse animal welfare and human safety issues.

These can include: Traffic accidents; damage to pasture, crops, gardens and fences caused by kangaroos; negative impact on vulnerable native vegetation or ar-

eas undergoing revegetation due to kangaroo grazing; competition for grazing with livestock on farming properties; kangaroos becoming aggressive towards people, usually when individual animals have regular contact with humans.

DEECA can issue Authorities to Control Wildlife (ATCW) under section 28A of the *Wildlife Act 1975* for the control of kangaroos where they are demonstrated to be damaging pasture, crops or other property or impacting on biodiversity values.

Any person wishing to control wildlife, including kangaroos, on their property is required to apply for an ATCW. Management techniques for kangaroo populations include fertility control, fencing, scaring and culling.

To apply for an ATCW, visit vic.gov.au/wildlife-management-and-control-authorisations

Chronic phalaris toxicity is also majorly affecting Victoria’s kangaroo population.

Kangaroos can develop chronic phalaris toxicity, or ‘staggers’, as

it is commonly referred to, which causes neurological damage in animals that have eaten Phalaris grasses (also known as canary grass). Phalaris is a common pasture crop that when grown under certain conditions can be toxic to animals that graze on it.

Symptoms commonly seen in kangaroos that have chronic phalaris toxicity poisoning include muscle tremors and abnormal or erratic movement, such as repeated falling over, giving the appearance that the kangaroo is drunk or staggering.

Currently there is no known treatment for this condition in wildlife and unfortunately animals severely affected often require euthanasia or humane killing for animal welfare reasons.

If you suspect a kangaroo with chronic phalaris toxicity poisoning, please contact your local vet or a wildlife rescue organization.

Rebuild costs surge

THE cost of rebuilding homes after extreme weather is rising faster than inflation with the biggest increases concentrated in the materials and trades needed most after disasters, according to new analysis released today by the Insurance Council of Australia.

Published as part of the Insurance Council's annual *Insurance Catastrophe Resilience Report*, the analysis highlights the growing economic cost of extreme weather and the increasing pressure it is placing on housing supply, construction costs and insurance affordability.

Data from Cotality's *Cordell Construction Cost Index (CCCI)* shows building costs rose around 30 per cent in the five years to March 2026, against CPI growth of about 24 per cent over the same period.

The sharpest increases occurred in the materials and trades most relied upon after disasters, with many costs rising at more than double

the CPI. Roof tiles increased 77 per cent in five years, more than three times the rate of CPI. Windows, plaster, plywood, copper piping, structural steel, cement and concrete climbed between 37 and 48 per cent. The cost of roof, windows and plaster products, elements commonly damaged by hail, storms and cyclones, saw some of the largest increases. Labour costs followed a similar trend, with roofers and glaziers recording the most significant wage growth.

Rising rebuild costs are placing pressure on insurance premiums, and this pressure is sharpest where the weather is worst.

Beyond the inflationary impact, the cycle of rebuilding and repairing homes damaged by extreme weather is diverting the materials, trades, and construction capacity needed to increase housing supply.

Between 2022 and 2026, insurers received more than

400,000 claims to repair or rebuild homes damaged in declared events, at an insured cost of \$11.3 billion.

In 2025 alone, declared events damaged 145,392 homes, almost as many as the 172,657 new homes completed nationally that year.

More generally, the report shows that in 2025-26 seven declared events generated more than \$3.98 billion in insured losses, up more than \$1.7 billion on the previous year.

ICA CEO Andrew Hall said, "Inflation in building costs is adding real pressure to the cost of premiums year on year. Every insurance claim draws on the same builders, trades and materials needed to deliver new housing, stretching an already constrained construction sector even further.

"The building sector has called out sustained labour shortages, higher electricity costs, and climbing prices for specific building materials as the key drivers of

inflation in Australia.

"Shifting market demands for AI data centre construction and the 2032 Olympic Games will add further demand into an already stretched sector.

"Combined with the exposure to high-risk weather in fastest growing regions of the country, Australia is in urgent need of a plan to tackle both the resilience and the costs of housing over the long term.

"Resilience investment, stronger homes and smarter planning decisions, combined with producing more skilled labour are critical to bringing downward pressure on these costs.

"Resilience investment is not just good disaster policy, it's good housing policy that stacks up economically.

"Australia will not tackle the housing shortage while disasters keep pushing existing homes back into the repair queue, which is why resilience investment must be a core part of the government's national housing strategy."

Be asthma-ready this spring

AS temperatures rise and Victorians look to spend more time outdoors, Ambulance Victoria is reminding the community to get ahead of the season and update their asthma action plans.

Spring conditions often present allergens and triggers for people living with asthma, and if unmanaged or not prevented, it can develop into a serious health concern.

Ambulance Victoria Director Emergency Management Dale Armstrong said early preparation is key.

"Asthma affects people of all ages and while it can become life-threatening, it is usually well managed when people understand their triggers and have an up-to-date asthma action plan," he said.

"An asthma action plan is one of the most important tools for managing your condition. It helps you recognise worsening

symptoms early and know exactly what steps to take."

Common spring triggers include pollen, dust, air pollution and thunderstorms, while indoor irritants such as mould, dust mites and fumes from gas cooktops can also contribute to asthma symptoms.

Thunderstorm asthma is thought to be triggered by a unique combination of large amounts of grass pollen in the air and a certain type of thunderstorm. For people who have asthma or hay fever, this can trigger severe asthma symptoms.

Symptoms to be mindful of include wheezing, shortness of breath, coughing and chest tightness.

"It can be easy to become complacent if you haven't experienced symptoms for a while, but asthma doesn't disappear," Dale said.

"That's why we encourage Victorians to check their

medication, review their action plan and book in with their GP before symptoms become a problem."

Adults should review their asthma action plan at least once a year, while children's plans should be updated every six months.

Asthma can also develop for the first time in adulthood. People experiencing persistent allergy or hay fever symptoms, such as a runny nose, itchy eyes or ongoing congestion, should speak with their GP about appropriate treatment and whether further assessment is needed.

"Taking simple preventative steps now can help people stay healthy and active throughout spring, while also reducing avoidable demand on ambulances and hospitals," Dale said.

"Always follow your asthma action plan, but if you are

having difficulty breathing and your reliever medicine is not helping, call Triple Zero (000) immediately."

For non-emergency care and advice, Victorians can access a range of alternate healthcare options, including: Virtual Emergency Department (VED) at ved.vic.gov.au, providing free video consultations with emergency doctors and nurses from anywhere in Victoria, 24 hours a day; Urgent Care Clinics, offering treatment for a range of non-life-threatening conditions; Nurse-On-Call on 1300 60 60 24 for free health advice from registered nurses, 24 hours a day, seven days a week; and Local GPs and pharmacists, who can provide timely advice, treatment and support for ongoing asthma management.

Victorians should monitor the epidemic thunderstorm asthma risk forecast on VicEmergency from October 1 to December 31.

Rural Councils Victoria seeks greater rural investment

RURAL Councils Victoria (RCV) has launched its statewide ‘Invest in Rural Victoria’ campaign, calling on all political parties and candidates to commit to greater investment in rural communities ahead of the Victorian election.

The campaign was launched in Swan Hill during the 2026 Rural Councils Victoria Forum, which brought together dozens of mayors, councillors and community leaders from across country Victoria.

At the centre of RCV’s election platform is a call for the establishment of a \$1 billion Rural and Regional Victoria Productivity and Growth Fund to support housing,

economic development, community infrastructure and stronger local councils.

The campaign is also calling for extra and sustained new funding for country roads, including both state and locally-managed roads.

RCV Chair Cr Rob Amos said more than one million Victorians live outside Melbourne and the big regional cities, and rural communities are a key engine room for the Victorian economy.

“Rural communities power Victoria. We grow the food, generate energy, attract visitors and support industries that benefit every Victorian, yet too often, rural Victoria is

being asked to do more with less.”

Cr Amos said the campaign was about securing ongoing investments that will boost liveability and economic activity in rural areas.

“Across Victoria there are projects ready to go. We have housing projects waiting to proceed, community facilities crying out for renewal and expansion, and economic development opportunities poised to create jobs and growth.

“We just need the Victorian Government to invest more in rural Victoria.”

The high-level campaign will be supported locally with community

signage at sites needing increased state investment and local meetings with election candidates and MPs.

Rural Councils Victoria is a non-partisan advocacy organisation representing the state’s 35 rural councils.

“This campaign is timed for the election, but it’s not about politics. It’s about outcomes,” Cr Amos said.

“Our message to all politicians and policymakers is the same: if you respect rural Victoria, you need to invest in rural Victoria.”

ALEXANDRA Speedway roared into action on the evening of Saturday, August 29 with the annual three-hour endurance teams' event plus Junior Sedans and Standard Saloons.

After a gruelling race with many of the pre-event favourites quests for victory undone by tyres, and damage through the race, Dale Smith, who by his own teammate's admission did most of the racing, won with his father Russell Smith much to the delight of their fellow competitors when it came to event presentations.

Alexandra put in place a new concept for the weekend where instead of qualifying for position, the fans would get involved with their children and the children would select team numbers from a bag, and that team would then start in the position they were drawn.

With a twist, Karl Dingly the Chief Steward of the event and Rod Meakins an Alexandra life member, put together \$300 dollars and offered the team of Nathan O'Brien and Josh Barber a deal to take, if they swapped positions with last drawn team of Kellie Latham and Josh Service, the \$300 would go to the Royal Children's Hospital as a donation.

Nathan and Josh did not hesitate to accept the deal and place themselves last, just a terrific gesture all round by Karl and Rod and then Nathan and Josh to accept.

In support racing prior to the three-hour enduro, Junior 1200cc Sedan competitors held their feature race in which Victorian champion Jaylin Knight defeated, Kobi Knight and Lucas Magor. In Standard Saloon racing, a last cor-

ner pass by longtime club stalwart Wayne Sheerman on visiting racer Colin Connolly, seen him snatch victory at the finish line by 0.072 of a second with Leigh Gooding coming to the line in third.

The Enduro then began with the top 10 line up of Latham and Service, then Jasmin Molloy and Lucas Conder, Nathan Miles and Andrew Mitchell, Wayne and Travis Ramsdale, Alexandra town locals Luke and Will Fallon, Darren O'Brien and Scott Chippindall, Jarrod Hughes and Steve Mitchell, Caleb Lincoln and father Colin Lincoln, Andrew Cormack and Conway Fry, and Anthony Sharam and Danny Eastham.

At the tail of the field were fancied teams such as O'Brien and Barber who took to the rear of the field challenge, plus David Donegan and Ian Thomsen on the second last row, Brendan and Damien Miller from position 20, and defending champions Shane O'Brien and Lennie Bonnici from 18.

When the green flag dropped, Josh Service grabbed the lead and led lap one from Andrew Mitchell and Travis Ramsdale with the Miller's moving up six spots into 14th on the first lap. The Lincoln's who had begun in seventh and eighth, were in third by the end of lap two and moving into second not long after. At the 10-lap mark Service had led every circulation with Team Lincoln's in second then Team Fallon's, then Brad Warren and Dave Hutchinson, and team Ramsdale's. The team of Hughes and Steve Mitchell had already suffered damage and tailed the field.

Team Lincoln took the lead at lap 12 from Service and the Millers moved into the top five. With cars having mechanical issues and tyres popping of the rims or just going

flat, the field yo-yoed up and down in terms of positioning. At lap 20 the Lincolns still held the lead from Service with the Millers now in third.

The pit stops started to begin for many of the capable of winning teams around lap 24 where the Ramsdale and the Fallon's for example entered the pit lane for a change over, the Lincoln's pitted on lap 25 handing the race lead back to Josh Service who would soon tag in Kellie Latham.

At lap 30, Service had not yet pitted although everybody knew it was coming. Lennie Bonnici was in second and Dale Smith in third ahead of the Gareth Wilson and Dave Barrie combination. That pit-stop for Service had not yet eventuated with 40 laps on the board.

Incredibly in an endurance race hard on the body despite, the safety belts and constricted seat that locks the driver in place, along with Bonnici, Dale Smith and some of the back of the field starters, the drivers were showing incredible durability with the O'Brien and Barber combination from 26th to fifth.

Service still led at lap 50 from Bonnici and Smith. With Jak Brennan and Matt Shankland, a new entry into the top five before Service headed to the pits on lap 53. With a larger fuel tank capacity, Bonnici soldiered on from first while Donegan and Thomsen hot the top five and were in third. Bonnici pitted to hand the reigns to teammate Shane O'Brien on lap 60. Smith held the lead until lap 84 before pit stops handed the lead to the Fallon's who had pitted earlier.

The Miller's hit the lead for the first time of the race for them on lap 76 and had like other teams been racing patiently to get to the

front avoiding non-necessary contact trying to pass cars they know they can fly by in a better spot. The Brennan/Shankland combination was in third spot at this stage.

It was at lap 126 that the Millers pitted and still returned to the track in second place incredibly. The Fallon's led from the Millers, Donegan/Thomsen, the Smith's and Shane Roycroft and Lee Beach who had recovered from early race mechanical inconveniences.

A couple of laps later the Donegan/Thomsen combination hit the front of the race with the Smith's up to second, the Fallon's back to third. Dale Smith snatched the lead again on lap 133 with the Fallon's and Roycroft/Beach teams in the top three.

Combinations such as Danny O'Brien and Rob Bushell found time in the top three as those cars that had formed the fast top 10 broke down or made scheduled stops. At lap 170, the Smith's still held the lead from the Fallon's, Donegan/Thomsen and the Ramsdale's and now O'Brien and Bushell.

From there the Smiths were never headed, had an easy change over between son back to father with no idea how in front they were when Dale's car started to cough. Russell raced the closing laps to the end where they had completed 216 and finished ahead by nine laps from the Ramsdale team, with Donegan/Thomsen in third place, Latham and Service fourth and Danny O'Brien and Rob Bushell in fifth, 13 laps down on the leader.

Just outside the top 10 were the likes of the Fallon team, the Miller's, Brennan and Shankland, with Sharam and Eastham delighted to be in the top 10 as were

Chippindall and Darren O'Brien in seventh.

After race presentations included awards to Wayne Sheerman, Jaylin Knight and the Donegan/Thomsen team for their team and car presentations. Plus, to Shane Roycroft and Lee Beach for being in the 10th spot at that time of the 69th lap of the race.

A huge honour was then bestowed on the race winners, when their peers voted them the most respected competitors of the event, as he accepted this acknowledgement, Dale Smith started by mentioning that such an award takes more significance than any race winning trophy can, in which Russell Smith concurred, it is nice to be recognised for where they stand in the racing community.
